2. **TO WAIVE ANY AND ALL CLAIMS** that I have or may in the future have against Tunnel49 Adventure Inc.
3. **TO RELEASE** Tunnel49 Adventure Inc. in the design, manufacture, selection, installation, maintenance or adjustment of the equipment;

ARBITRATION: In further consideration of the sale to me of the listed stand up paddle boarding, Supsquatch, kayaking or canoe equipment, I hereby agree to submit to binding arbitration any and all claims which I believe I may have against Tunnel49 Adventure Inc. arising from any use of the listed stand up paddle boarding, Supsquatch, kayaking and canoe equipment. This agreement shall be governed by and interpreted in accordance with the laws of the Province of British Columbia. **THE PARTIES TO THIS AGREEMENT UNDERSTAND THIS SECTION CONTAINS AN AGREEMENT TO ARBITRATE. AFTER SIGNING THIS AGREEMENT, EACH PARTY UNDERSTANDS IT WILL NOT BE ABLE TO BRING A LAWSUIT CONCERNING AND DISPUTE THAT MAY ARISE WHICH IS COVERED BY THIS SECTION, UNLESS IT INVLOVES A QUESTION OF CONSTITUTIONAL OR CIVIL RIGHTS. INSTEAD EACH PARTY AGREES TO SUBMIT SUCH DISPUTE TO IMPARTIAL ARBITRATIONS IN ACCORDANCE WITH THIS SECTION.**
